Week Seven

Week seven was yet another busy week for the legislature as the opposite policy house committee cutoff was on Wednesday. That means if a bill was introduced in the House, it needed to pass through its policy committee in the Senate to still be considered alive, and vice versa for Senate legislation. Legislators are now working late nights and this weekend to move bills through fiscal committees before the opposite house of origin fiscal committee cutoff on Monday, February 26. Following the opposite house fiscal cut-off, both the House and Senate will head to the floor to pass bills out of their respective chambers.

In the second half of the biennium, the legislature is tasked with passing supplemental Capital, Operating, and Transportation budgets. Over the weekend and early this week, the House and Senate released their proposed budgets. Negotiations between House and Senate budget writers will continue over the next two weeks until they reach an agreement and pass the final supplemental budgets. The 2024 legislative session adjourns sine die on March 7th. Since the budget is a supplemental budget, in theory, the legislature can adjourn without passing anything and defer back to the budget passed in 2023. Detailed below is more information on the three budgets.

Sine die does not mark the end of a busy schedule for legislators. It is a significant campaign year, with half the Senate and the entire House of Representatives up for re-election, along with statewide and congressional races opening up. There will be significant movement in the legislature as a result. Recently, Senator Sam Hunt voiced that he is not running for re-election, and Representative Bateman announced she will be running for his seat. With Cathy McMorris Rodgers not running for re-election for the 5th Congressional District, Representative Maycumber has announced her candidacy. Many more announcements are expected, and we will provide updates with additional announcements as they arrive.

Key Issues Before the Legislature - Week 7:

- **Linkage to California & Quebec** - SB 6058, works to link Washington State's CCA carbon market with California and Quebec. There has been a lot of speculation surrounding whether this bill is an alternative to Initiative 2117 - if so, the bill will need to be put in front of the voters. The bill had a [public hearing in House Appropriations](#) on Friday where Proponents voiced that this bill will help continue the cap and invest program without increasing costs. It is now scheduled for an executive session on [Monday, February 26th](#).

- **Keep Our Care Act** - [SB 5241](#) works to implement AG approval for mergers and affiliations of hospitals - however, it reaches further and includes physician groups as well. The bill moved through the legislative

process in the Senate last year where it eventually died in Rules. Since bills pickup in the biennium from the highest location that they made it in the previous year, the bill was pulled out of Senate Rules earlier this month and voted to the House where it has continued to move through the legislative process. Advocates worry that consolidation could raise healthcare costs and reduce services previously provided, while critics argue the bill adds too many requirements for mergers, possibly hindering deals. This might harm smaller hospitals and clinics needing support from larger institutions to stay open. A public hearing in House Appropriations was held on Friday, February 23rd. The bill is now scheduled for executive session on [Monday, February 26th](#).

Insight - Week 7:

- **Budgets** - This week, the legislature spent a lot of time on holding public hearings, executive sessions, and floor debates on the Capital, Operating, and Transportation budgets. All of the bills have been moved out of their originating Chambers. Negotiations on final supplemental budgets are now underway.
 - **Capital Budget** - The Senate released its \$1.3 billion 2024 Supplemental Capital Budget Proposal which suggests significant funding of K-12 construction, Behavioral Health Facilities, and Affordable Housing.

 - **Operating Budget** - The budget proposals from the chairs of the Senate and House for the 2023–25 period propose significant appropriations increases with the Senate suggesting a \$1.854 billion increase and the House increasing the budget by \$2.196 billion. This will add about \$1.9 billion on top of the biennial budget that was passed last year. These proposed increases cover both the maintenance level adjustments (essential modifications to maintain existing services, reflecting changes in enrollment and inflation) and the introduction of new policy measures. Significant money is dedicated to K-12 education, behavioral health, the opioid crises, housing and homelessness, and public health. [Click here](#) to read more from the Washington Research Council.

 - **Transportation Budget** - The Senate outlines a \$14.6 billion proposal for the supplemental transportation budget, focusing on public safety, the Washington ferry system, salmon ecosystem restoration, and infrastructure maintenance. It includes a new investment of \$875 million for the I-5 Columbia River Bridge project, with significant funding from the Climate Commitment Act.

- **Initiatives Update** - Democrats have voiced that they will not hold public hearings on [I-2117](#) (works to repeal the two-year-old Climate Commitment Act), [I-2109](#) (works to repeal the capital gains excise tax), and [I-2124](#) (which repeals the Washington Cares Fund). These bills will go to the ballot in November for a vote.
 - **Three of the six initiatives will have public hearings held next week:**
 - [I-2111](#), which seeks to codify Washington state's longstanding tradition of prohibiting state and local personal income taxes, has a public hearing in front of Senate Ways & Means and House Finance Joint Committee on [February 27th](#).
 - [I-2113](#), which seeks to restore vehicular pursuit laws, has a public hearing on [February 28th](#) in front of a joint Senate Law & Justice and House Community Safety, Justice, & Reentry committee.
 - [I-2081](#), which seeks to establish a parents' bill of rights, has a public hearing in front of a joint Senate Early Learning & K-12 Education and House Education Committee on [February 28th](#).

CleanTech Alliance Specific Issues - Week 7:

Budget: Reminder, provisos do not get funded just for being in the proposal. For a proviso to be funded, language needs to be included in the final budgets negotiated and then passed into law. The sewer heat recovery project was included in the Senate Operating budget proposal. The fusion energy cluster was included in the House Operating budget proposal. We will continue to work on advocating for those projects to be included in the final budget.

Bills that Survived Cutoff:

- Representative Shavers' bill [HB 1924](#), promoting the integration of fusion technology within state clean energy policies, was voted off the House floor on February 6 (95-2). The bill received a do pass recommendation in the Senate Environment [Tuesday, February 20th](#). It now sits in Senate Rules.
- Representative Ramel's thermal energy networks bill for gas utilities, [HB 2131](#), received a do pass recommendation in the Senate Committee on Environment, Energy & Technology on [Tuesday, February 20th](#). It was then heard in the Senate Ways & Means Committee on [Friday, February 23rd](#) and is scheduled for a public hearing on [Monday, February 26th](#). This bill was referenced in the House budget proposal.
- The Senate vehicle for the carbon market linkage bill, [SB 6058](#), continues to move through the legislative process. It received a do pass recommendation in the House Environment & Energy Committee on [Tuesday, February 20th](#), followed by a hearing in the House Appropriations Committee on [Friday, February 23rd](#). Executive session is scheduled for [Monday, February 26th](#).
- Senator Shewmake's bill, [SB 6092](#), which concerns the disclosure of greenhouse gas emissions, received a do pass recommendation in the House Environment & Energy Committee on [Tuesday, February 20th](#), followed by a hearing in the House Appropriations Committee on [Friday, February 23rd](#). Nobody testified on the bill during the public hearing. Executive session is scheduled for [Monday, February 26th](#).
- [HB 2401](#), sponsored by Representative Duerr, deals with providing for the responsible management of refrigerant gasses with a higher global warming potential than carbon dioxide that are used in appliances or other infrastructure. The bill received a do pass recommendation in the Senate Environment, Energy & Technology Committee on [Tuesday, February 20th](#). It had a public hearing in the Senate Ways & Means Committee on [Saturday, February 24th](#), and is scheduled for executive session on [Monday, February 26th](#).
- Rep. Doglio's bill, [HB 1589](#), works to support Washington's clean energy economy and transitioning to a clean, affordable, and reliable energy future. The bill was pulled from Rules on Friday, February 23rd and placed on second reading. It now awaits third reading on the House floor for debate and vote.
- [HB 2020](#), sponsored by Representative Timmons, authorizes the Military Department to administer a program for emergency assistance to county governments and federally recognized tribes that experience public infrastructure damage due to a natural, technological, or human-caused disaster. The bill received a do pass recommendation in the Senate State Government & Elections Committee on [Tuesday, February 20th](#), had a public hearing in the Senate Ways & Means Committee on [February 24th](#), and is scheduled for executive session on [Monday, February 26th](#).
- [HB 2069](#), concerning the sale of biogenic carbon dioxide and other coproducts of biogas processing. The bill received a do pass recommendation on [Tuesday, February 20th](#) in the Senate Committee on Environment, Energy & Technology. It now sits in Senate Rules.

Bills that Appear Dead:

*Reminder that bills are never actually dead until the end of session

- Representative Barnard's Tax Preferences for Clean Energy Manufacturers bill, [HB 2120](#), had a [public hearing](#) on Tuesday, February 20, in front of the Senate Environment, Energy & Technology Committee

however it failed to make it out of committee prior to Wednesday's cutoff and is now considered dead for this session.

- The Re-WRAP Act, [HB 2049](#), never got pulled onto the House floor for a vote and is considered dead for the session.
- Representative Slatter's bill, [HB 2073](#), regarding greenhouse gasses from sources other than methane and carbon dioxide was not pulled to the House floor by a member before the House of Origin cutoff and is considered dead for the session.
- Senator Mullet introduced legislation to provide a state B&O tax exemption to encourage clean technology manufacturing in Washington ([SB 6243](#)). It did not move out of its house of origin policy committee prior to the cutoff.
- Representative Barnard has introduced legislation aimed at establishing the development of renewable energy for the Washington revolving loan program and account ([HB 2417](#)). The bill never moved out of its house of origin policy committee and is considered dead.
