

2024 Legislative Session Weekly Report CleanTech Alliance February 16, 2024

Week Six

Tuesday served as a critical cutoff for the 2024 legislative session, with all proposed legislation required to advance from its originating chamber to remain alive. Debates on bills had to start by 5:00 PM on the cutoff day to qualify for consideration. In the lead-up to this deadline, the legislature engaged in extensive discussions on numerous issues. The more contentious bills took a substantial amount of time which resulted in bills not progressing past the House and Senate floor calendars.

Starting first thing Wednesday morning, legislators returned back to their respective policy committees to work on bills coming over from the other chamber. They will continue to hold public hearings and run bills through executive action until the opposite house policy committee cutoff which is on February 21st.

Following the Washington State Economic and Revenue Forecast Report released early this week, the Senate released its Capital Budget Proposal. It is anticipated that the House will release theirs next week. We also anticipate that the House and Senate Operating and Transportation Budget Proposals are expected to come out next week as well. Key Issues Before the Legislature - Week 6:

- State Elections Database Bill SB 5837, concerning the state elections database, aims to codify the state's digital election database and provide public access to a wide range of voting data. Supporters argue it's a necessary public service, while opponents raise concerns about potential political bias and misuse of the data for litigation purposes. The bill passed in the Senate along party lines and is headed to the House for consideration.
- **Rent Stabilization Bill** <u>HB 2114</u> proposes a 7% cap on annual rent increases, alongside other limits on security, late fees, and moving costs. If enacted, it would also empower the Attorney General to enforce provisions under the Consumer Protection Act and mandate the creation of a website to publish information on rent and fee increases. Supporters argue it will address housing insecurity and prevent excessive rent charges, especially affecting vulnerable groups like seniors and low-income tenants. Critics, however, fear it could destabilize the housing market, reduce supply, and ultimately increase rents. <u>Read more on King 5</u>.
- **Grocery Worker Employment Bill** <u>SB 6007</u>, concerning the employment of grocery workers during store mergers, mandates that existing employees be retained by the new company for at least 180 days postmerger, or be compensated for the same period if not retained. This bill aims to protect grocery workers,

ensuring continuity and stability during mergers, especially in areas where access to quality, affordable food is limited.

Insight - Week 6:

- The **Washington State Economic and Revenue Forecast Council** released its <u>Economic & Revenue</u>

 <u>Forecast</u> on February 14th (Click <u>here</u> to watch the council meeting). These are the numbers the legislature looks towards to generate the budget. According to the Forecast, total state revenue is expected to increase by \$121.8 million in the 2023-2025 biennium and \$215.4 million in the 2025-2027 biennium.
 - The future holds uncertainty regarding the Capital Gains tax, as its repeal will be decided by voters in November. Should the repeal occur, the Office of Financial Management (OFM) projects a minimum revenue reduction of between \$1.6 billion and \$2.13 billion for each two-year period over the next six years.

- **Budget -** The Senate released its \$1.3 billion 2024 Supplemental <u>Capital Budget Proposal</u> which suggests significant funding of K-12 construction, Behavioral Health Facilities, and Affordable Housing.

- **Initiatives Update** Democratic leaders in the Washington Legislature announced they will not hold hearings on three of the initiatives repealing the state's capital gains tax, repealing of the Climate Commitment Act, and an opt-out of the long-term care program, indicating these proposals will instead go to the November ballot without legislative action. Read more on the Seattle Times. The other three initiatives will be heard in the House and Senate on February 27th and 28th.

CleanTech Alliance Specific Issues - Week 6:

Bills that Survived Cutoff:

- Representative Shavers' bill <u>HB 1924</u>, promoting the integration of fusion technology within state clean energy policies, was voted off the House floor on February 6 (95-2). The bill had a <u>public hearing</u> in front of the Senate Environment on Wednesday and is scheduled for executive session on Tuesday, February 20.
- Representative Ramel's thermal energy networks bill for gas utilities, <u>HB 2131</u>, was pulled to the floor for a vote on Friday and passed out of the House unanimously. The bill has a <u>public hearing</u> in front of the Senate Committee on Environment, Energy & Technology on Tuesday, February 20.
- The Senate vehicle the carbon market linkage bill, <u>SB 6058</u>, continues to move through the legislative process. It is scheduled for a <u>public hearing</u> on Monday, February 19, and <u>executive session</u> on Tuesday, February 20th.
- Senator Shewmake's bill, <u>SB 6092</u>, which concerns the disclosure of greenhouse gas emissions was pulled to the Senate floor for debate on Tuesday, February 13, and was voted off the floor (30-19). The bill has moved to the House and is scheduled for a <u>public hearing</u> in front of the House Committee on Environment & Energy on Monday, February 19, and <u>executive session</u> on Tuesday, February 20.

- Representative Ramel's thermal energy networks bill for gas utilities, <u>HB 2131</u>, was pulled to the floor for a vote on Friday and passed out of the House unanimously. The bill has been scheduled for a <u>public hearing</u> in front of the Senate Committee on Environment, Energy & Technology on Tuesday, February 20.
- Representative Barnard's Tax Preferences for Clean Energy Manufacturers bill, <u>HB 2120</u>, was pulled onto the House floor for a vote where it passed to the Senate (94-1). The bill has a <u>public hearing</u> on Tuesday, February 20, in front of the Senate Environment, Energy & Technology Committee.
- <u>HB 2401</u>, sponsored by Representative Duerr, deals with providing for the responsible management of refrigerant gasses with a higher global warming potential than carbon dioxide that are used in appliances or other infrastructure. The bill had a <u>public hearing</u> in front of the Senate Committee on Environment, Energy & Technology on February 14 and is scheduled for <u>executive session</u> on Tuesday, February 20.
- Rep. Doglio's bill, <u>HB 1589</u>, works to support Washington's clean energy economy and transitioning to a clean, affordable, and reliable energy future. On Friday, <u>executive action</u> was taken on the bill in the Senate Environment, Energy & Technology Committee where they considered two amendments (<u>Senator MacEwan's amendment</u> and <u>Senator Nguyen's amendment</u>). Senator Nguyen's amendment hung and the bill passed out of committee on party lines. The bill is now referred to its fiscal committee for further consideration.
- <u>HB 2020</u>, sponsored by Representative Timmons, authorizes the Military Department to administer a program for emergency assistance to county governments and federally recognized tribes that experience public infrastructure damage due to a natural, technological, or human-caused disaster. On Tuesday, the bill passed of the House floor unanimously. The bill had a <u>public hearing</u> in front of the Senate State Government & Elections Committee on Friday and is now scheduled for <u>executive session</u> on Tuesday, February 20.
- <u>HB 2069</u>, concerning the sale of biogenic carbon dioxide and other coproducts of biogas processing. The bill passed off the House floor unanimously on Monday. It is scheduled for a <u>public hearing</u> on Tuesday, February 20 in front of the Senate Committee on Environment, Energy & Technology.

Bills that Appear Dead:

*Reminder that bills are never actually dead until the end of session

- The Re-WRAP Act, <u>HB 2049</u>, never got pulled onto the House floor for a vote and is now considered dead for the session.
- Representative Slatter's bill, <u>HB 2073</u>, regarding greenhouse gasses from sources other than methane and carbon dioxide was not pulled to the House floor by a member before the House of Origin cutoff and is considered dead for the session.
- Senator Mullet introduced legislation to provide a state B&O tax exemption to encourage clean technology manufacturing in Washington (<u>SB 6243</u>). It did not move out of its house of origin policy committee prior to the cutoff.
- Representative Barnard has introduced legislation aimed at establishing the development of renewable energy for the Washington revolving loan program and account (<u>HB 2417</u>). The bill never moved out of its house of origin policy committee and is considered dead.

<u>Important Dates</u>: Initiatives and bills that are necessary to implement the budget (NTIB) are all exempt from these deadlines.
